

In terms of the Financial Services and Markets Act 2000 (“FSMA”) and the Financial Services and Markets Act 2000 (Financial Promotion) Order 2005 (as amended), business angels may only receive financial promotions if they are either a “**certified high net worth individual**”, “**self-certified sophisticated investor**” or a “**certified sophisticated investor**”. If you are in either of these categories then you are exempt from the provisions of the FSMA. It is a legal requirement that you can exhibit suitable documents to this effect prior to completion of any investments as a member of Co Angel Investment Limited (“Co Angel”).

To satisfy the requirements of the FSMA you must do one of three things:

1. Sign a Declaration that you are a “Certified High Net Worth Individual”:

The prescribed form of wording is shown on page 2 overleaf. Please note that a Statement to this effect must be signed on an annual basis.

We anticipate that anyone wishing to join Co Angel as a new member or renewing their membership after a period of non-membership of 6 months **or** more will want to make use of this option.

2. Sign a Declaration that you are a “Self-Certified Sophisticated Investor”:

The prescribed form of wording is shown on page 3 overleaf. Please note that a Statement to this effect must be signed on an annual basis.

We anticipate that anyone who is a current member of Co Angel (and has been for at least 6 months on a continuous basis) will want to make use of this option.

3. Sign a Declaration that you are a “Certified Sophisticated Investor” and also obtain a Certificate from an Authorised Person confirming that this is the case:

The prescribed form of wording is shown on page 4 overleaf. Please note that a Declaration to this effect must be signed by you on an annual basis, although an authorised person need only sign the Certificate (comprising part 2 of the Statement) once every three years.

We anticipate that this option will only be used by new members of Co Angel who do not meet the net asset or annual income test referred to the Certified High Net Worth Individual Declaration (per option 1 above).

Statement for Certified High Net Worth Individual

I the undersigned declare that I am a certified high net worth individual for the purposes of the Financial Services and Markets Act 2000 (Financial Promotion) Order 2005.

I understand that this means:- (a) I can receive financial promotions that may not have been approved by a person authorised by the Financial Services Authority; (b) the content of such financial promotions may not conform to rules issued by the Financial Conduct Authority; (c) by signing this statement I may lose significant rights; (d) I may have no right to complain to either of the following: (i) the Financial Conduct Authority; or (ii) the Financial Ombudsman Scheme; and (e) I may have no right to seek compensation from the Financial Services Compensation Scheme.

I am a certified high net worth individual because **at least one of the following applies:-**

(a) I had, during the financial year immediately preceding the date below, an annual income to the value of £100,000 or more; or (b) I held, throughout the financial year immediately preceding the date below, net assets to the value of £250,000 or more.

“net assets” for these purposes do not include:- (i) the property which is my primary residence or any loan secured on that residence; (ii) any rights of mine under a qualifying contract of insurance within the meaning of the Financial Services and Markets Act 2000 (Regulated Activities) Order 2001; or (iii) any benefits (in the form of pensions or otherwise) which are payable on the termination of my service or on my death or retirement and to which I am (or my dependants are), or may be, entitled.

Statement for Self-Certified Sophisticated Investor

I am aware that it is open to me to seek advice from someone who specialises in advising on investments.

Statements for Certified Sophisticated Investor

Part 1 – Statement to be signed by the investor:
